YOUR MUSEUM: SOUND GOVERNANCE AND ACCOUNTABILITY

The Stratford Perth Museum is operated by the Stratford-Perth Museum Association, a not-for-profit organization and a registered charity.

- Annual meeting every February, where the membership elects the board of directors which in turn appoints the executive committee.
- Board averages 10 15 members who serve three-year terms with a limit of two consecutive terms.
- Two de facto members of the board are appointed from the Museum's municipal funding partners the City of Stratford and the County of Perth.
- Museum's external auditor presents audited financial statements for the just-ended fiscal year. The statements are distributed before the annual general meeting and are available on the Museum's website.

A WELL-RUN LEGACY FUND

The Museum's Legacy campaign will form the basis of a segregated Legacy Fund that will ensure the Museum's capacity to continue to preserve and present Stratford's and the County's rich culture for many generations to come. As with most endowment-based funds, Museum operations will only have access to accrued interest revenue, which will only be spent on approved initiatives. No amount of principal will be expended without the approval of the membership.

The Museum is establishing a Legacy Oversight Committee, which will operate at arm's-length from the Museum's board of directors. The committee will oversee and administer the Legacy Fund, including production of an annual report and presentation of recommendations to the board and to the membership regarding allowable withdrawals, investment strategies and other issues that arise.

THE NEED FOR A LEGACY

FUND

A museum in Stratford and Perth County has been around, in one form or another, for over 100 years.

The Museum's path has not always been easy. For the first century the Museum and its artifacts frequently changed locations, and only when the Museum set up shop at its current location in 2009, was it able to put down roots and have some stability.

In March 2020, the Museum was faced with a new challenge as the pandemic forced the Museum's closing for 55 of the next 92 weeks. The Museum has survived COVID to date through carefully orchestrated business strategy and unprecedented government support. The pandemic exposed the Museum's vulnerability to crisis, and while it survived, many museums did not.

It's important to know that the City of Stratford and the County of Perth provide the Museum with just under half of its annual operating expenses, while the rest, as well as all capital expenses, are raised through the hard work of staff and volunteers.

Smart organizations learn from crisis and hardship, and so has the pandemic provided instruction to the Museum's administration. Board and staff agree on the clear need to ensure the Museum's long-term sustainability through a funding strategy that will not just limit the impacts of a future crisis, but also build a foundation to allow your Museum to thrive under any circumstances.

Thus is the Legacy campaign born: an endowment strategy with a goal of \$2.5 million that will be vital to the Museum's future.



The interest from the fund will be used to seed capital projects, create new programs and exhibits or, most importantly, keep the lights on if faced with another crisis.
